



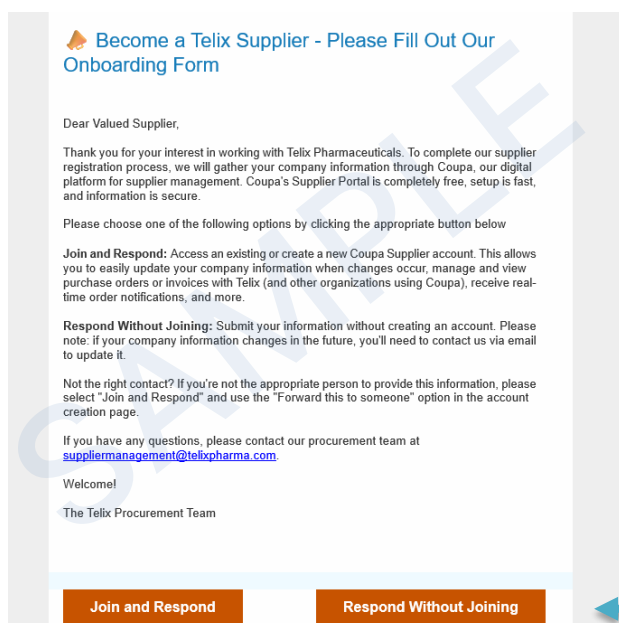

ONBOARDING

Telix utilizes the [Coupa Supplier Platform](#) to manage supplier relationships and procurement activities globally. When onboarding as a Telix partner, you'll work with a Telix Engagement Owner. This is your primary Telix contact who oversees your business relationship and potential engagement (Contract, Purchase Order, etc.).

Your Telix Engagement Owner will initiate your onboarding in Coupa, and the contact they designate will receive an email from Coupa requesting onboarding information. Completing this registration is required to begin working with Telix.
